NON-RESIDENTIAL ALARM PERMIT INFORMATION

The City of Tracy revised the current ordinance (3.40 TMC) establishing guidelines for the use of alarm systems within in the City. The revised ordinance became effective January 1, 2007.

The Ordinance Allows For:

- ◆ Annual Permit Fee of \$24.00 (July 1 to June 30th)
- ◆ Fees for false alarms
 - First 2 false alarms – warning letter
 - 3rd false alarm – citation (\$100)
 - 4th false alarm – service fee of \$32 and citation (\$200)
 - 5th false alarm – service fee of \$58 and citation (\$500)
- ◆ Fees and/or citations for failure to obtain a permit
- ◆ Alarm can be placed on a “non-response” list after the 5th false alarm in a twelve month period
- ◆ Alarms placed on the “non-response” list must be repaired and certification of the repair shall be presented to the Police Department in order to be removed from the “non-response” list

The Ordinance Requires:

- ◆ All alarm users obtain a permit for their alarm system annually (July 1st thru June 30th)
- ◆ Alarms shall be maintained in good working order
- ◆ The Police Department be notified within 5 days of any changes to permit information
- ◆ If ownership is changed during the year, a new permit must be obtained by new owner
- ◆ If notification is received by the Police Department showing a failure to obtain a permit, the Police Chief or his representative can demand the owner or lessee disconnect the alarm system until a permit is obtained.

Filing Alarm Permit Application:

- ◆ Fill out the alarm permit application completely
- ◆ Mail or deliver the application and \$24.00 fee to the Records Unit of the Police Department.
